1 The Court, having considered Plaintiff, Jeanne E. Caldwell's , Motion for
2 Administrative Relief as well as any opposition filed by defendants, rules as follows:

3 The Court grants Plaintiff's Motion for Administrative Relief by issuing the following
4 written clarification of the Court's March 13, 2006 Order granting defendants Roy L. Caldwell
5 and David Lindberg's (the "UC Defendants") Motion to Dismiss pursuant to F.R.C.P. 12(b)(6):

6 The March 13, 2006 Order is deemed amended to state that the UC Defendants' Motion
7 to Dismiss pursuant to Rule 12(b)(6) is granted with leave to Plaintiff to file an Amended
8 Complaint as against the UC Defendants within ten (10) days after the date of entry of this Order
9 on Plaintiff's Motion for Administrative Relief; [or in the alternative]

10 The March 13, 2006 Order is deemed amended to state that the UC Defendants' Motion
11 to Dismiss pursuant to Rule 12(b)(6) is granted with leave for Plaintiff to file, within ten (10)
12 days after the date of entry of this Order on Plaintiff's Motion for Administrative Relief, a
13 Motion for Leave to File an Amended Complaint as against the UC Defendants; [or in the
14 alternative]

15 The March 13, 2006 Order is deemed amended to include an express ruling denying
16 Plaintiff's oral motion for leave to file an Amended Complaint as against the UC Defendants that
17 was made during the oral argument on the UC Defendants' Motion to Dismiss, since inclusion of
18 the Additional Allegations described in Plaintiff's Motion for Administrative Complaint in a
19 Amended Complaint still would not satisfy Plaintiff's obligation to plead legal standing to bring
20 her Establishment Clause Claim as against the UC Defendants.
